PART A: PHOTO/MODEL RELEASE

For and in consideration of my engagement as a model by Camden County, hereafter referred to as the photographer, on terms or fee hereinafter stated, I hereby give the photographer, his legal representatives and assigns, those for whom the photographer is acting, and those acting with his permission, or his employees, the right and permission to copyright and/or use, reuse and/or publish, and republish photographic pictures or portraits of me, or in which I may be distorted in character, or form, in conjunction with my own or a fictitious name, on reproductions thereof in color, or black and white, made through any media by the photographer at his studio or elsewhere, for any purpose whatsoever, including the use of any printed matter in conjunction therewith.

I hereby waive any right to inspect or approve the finished photograph or advertising copy or printed matter that may be used in conjunction therewith or to the eventual use that it might be applied. I hereby warrant that I am **(circle one) under / over** eighteen years of age and competent to contract in my own name insofar as the above is concerned. There will be no compensation for the use of my photo or photos

I hereby release, discharge and agree to save harmless the photographer, his representative, assigns, employees, or any person or persons, corporation or corporations, acting under his permission or authority, or any person, persons, corporation or corporations, for whom he might be acting, including any firm publishing and/or distributing the finished product, in whole or in part, from and against any liability as a result of any distortion, blurring, or alteration, optical illusion, or use in composite form, either intentionally or otherwise, that may occur or be produced in the taking, processing or reproduction of the finished product, its publication or distribution of the same, even should the same subject me to ridicule, scandal, reproach, scorn or indignity.

PART B: RELEASE & WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

HEREBY RELEASES, WAIVES, DISCHARGES, AND INDEMNIFIES Camden County, North Carolina, The North Carolina Department of Transportation, The Camden County Division of Parks and Recreation, the Dismal Swamp Welcome Center and the Dismal Swamp State Park, South Mills, North Carolina, employees and agents of the aforementioned municipalities, all sponsors, volunteers, owners of property used in the event, transporters, and other participants, all for the purpose herein referred to as "releasees," and saves them harmless from and against any and all claims, damages, liability, costs and expenses in connection with loss of life, personal injury, and/or damage to property arising from or out of any occurrence associated with participating in, observing, entering or exiting the event.

EACH OF THE UNDERSIGNED expressly acknowledges and agrees that the activities at the event by their nature are dangerous and involve the risk of serious injury and/or death and/or property damage. **EACH OF THE UNDERSIGNED** further expressly agrees that the foregoing release, WAIVER and indemnity agreement is intended to be as broad and inclusive as is permitted by the laws governing the towns, cities, counties and states where this event is being conducted and that if any portion thereof is held as invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no oral representations, statements, or inducement apart from the foregoing written agreement have been made.

This release, waiver and indemnification agreement specifically embraces each and every phase of the event sanctioned, authorized, offered and/or promoted by said releasees during the entire event and applies to every activity and/or service of the event therein mentioned, and has the same effect as if executed after each and every activity of the event in which the undersigned participates so that the parties herein intended to be released and indemnified shall be fully and effectively released and indemnified as to the entire event hereinabove described.
